

#### TERMS AND CONDITIONS FOR ROCHFORD MEMBERSHIP 12 MONTH CONTRACTS

#### **AGREEMENT**

Rochford Wines Pty Ltd does not sell alcohol to persons under the age of 18. By participating in our Membership Program, you confirm that you are over the age of 18. Rochford Wines Pty Ltd makes every effort to ensure that alcoholic beverages are not delivered to anyone who is under the age of 18. By participating in our membership program you are acknowledging that the person receiving a shipment of alcoholic beverages from Rochford Wines Pty Ltd is over the age of 18.

If you intentionally or unintentionally misrepresent your age in order to provide alcohol to a person under the age of 18, Rochford Wines Pty Ltd will prosecute you to the full extent allowable by law. If the person receiving the wine is unable to produce appropriate ID, our couriers will be unable to leave the wine.

WARNING Under the Liquor Control Reform Act 1998 it is an offence to supply alcohol to a person under the age of 18 years. The penalty exceeds \$7,000. It is an offence for a person under the age of 18 years to purchase or receive liquor. The penalty exceeds \$600. Licence No. 32606438

# IF YOU DO NOT AGREE WITH THESE CONDITIONS YOUR MEMBERSHIP WILL NOT BE ACCEPTED BY ROCHFORD WINES

Your order is an offer to buy from Rochford Wines and to participate in our Membership program. There will be no contract of any kind between you and Rochford Wines Pty Ltd unless and until we accept your order, and in the case of wines and goods to be delivered to you, when we debit your credit card. We will collect your credit card information purely for the use to charge the order of your wines to your credit card as a part of the Membership program. By joining a Rochford membership, you agree to give Rochford Wines the right to charge your credit card for the agreed charges pertinent to the membership you are signing.

#### **Rochford Member:**

As a Rochford Member to qualify you have to order 6 or more bottles of wines from Rochford Wines in one purchase; your membership commences on your first order date.

You are entitled to purchase additional wines at the agreed Rochford Membership offer of 15% off for 6 to 11 bottles, 20% off for 12 or more bottles in one transaction. Not all Rochford Wines are available for discount\*.

#### Silver+ Member:

As a Silver+ Member, you and Rochford Wines agree you will purchase 24 bottles of Rochford Wines from the participating wines available within the program, in a 12-month period. Your membership commences on your first order date.

Within the agreed 12-month period, you will provide Rochford Wines your legitimate current credit card details which will be the credit card you authorize Rochford Wines to apply charges to, for the purchases of wines related to your membership.

At the time of completing your initial Membership order, you agree to purchasing a minimum of 12 bottles (first order) upfront, with a further order of an additional 12 bottles (second order) to be pre-ordered and a date of delivery for the second order specified. If you wish to change your pre-ordered wines, you must get in contact with a Rochford Wines representative at least 2 x weeks prior to shipment date.

As a Silver + Member you agree that your legitimate credit card will be charged 1 x week prior to shipment date.

Note: minimum quantity order 12 bottles. No six packs, 8 packs or mixed numbers packs.



#### Gold+ Member:

As a Gold+ Member, you and Rochford Wines agree you will purchase 48 bottles of Rochford Wines from the participating wines available within the program, in a 12-month period. Your membership commences on your first order date.

Within the agreed 12-month period, you will provide Rochford Wines your legitimate current credit card details which will be the credit card you authorize Rochford Wines to apply charges to, for the purchases of wines related to your membership.

At the time of completing your initial Membership order, you agree to purchasing a minimum of 24 bottles (first order) upfront, with further orders making up an additional 24 bottles (2 x 12 bottle orders – second and third order) to be preordered and a date of delivery for the second and third order specified. If you wish to change your pre-ordered wines, you must get in contact with a Rochford Wines representative at least 2 x weeks prior to shipment date.

As a Gold+ Member you agree that your legitimate credit card will be charged 1x week prior to shipment date.

Note: minimum quantity order 12 bottles. No six packs, 8 packs or mixed numbers packs.

## For All Memberships:

**Note**: Standard shipping is \$12.00 per dozen capped at \$24.00. Silver+ and Gold+ members receive free shipping on membership commitment orders only; any additional orders are subject to standard shipping. Free shipping is excluded from all special wine offers.

\*Note: some exclusions apply, not all Rochford Wines are available for purchase or discount within the Membership program. Wines not included within the Membership program for special discounts are: Rochford Club label wines.

\*Note: For Silver + and Gold+ Members, additional Cellar Door purchases attract your membership discounts, but do not contribute to your membership requirements and may not be counted as forward orders.

\*Note: Wines chosen for future shipments are subject to availability. Rochford Wines reserves the right to substitute wines selected with follow on vintages or a similar wine if a chosen wine is not available at the time of shipment. \*Rochford Wines reserves the right to change which wines are or are not included within the Membership programs.

If you are a Silver+ or Gold+ Member, you are eligible to receive vouchers from Rochford Wines. These vouchers are not eligible to use towards your membership requirements. <u>Vouchers are only available for online purchases at www.rochfordwines.com.au</u>

Rochford Restaurant benefits for Silver+ and Gold+ members are only available on a la carte and beverages purchases charged to your table. Silver+ members receive 15% off to a maximum discount of \$50 per table. Gold+ members receive 25% off to a maximum discount of \$100 per table. Member benefits do not extend to Group package and functions bookings or special menu days with a set price unless stipulated. Member Restaurant benefits cannot be used in conjunction with any other discounts or offers.

Silver+ and Gold+ members will receive 25% off Concert packages for Isabella's Restaurant and Garden Bar for you and your guest at selected concerts where these packages are offered. To receive the discount, your membership must be current at the time of the concert. There is a limit of two tickets per membership per event. Discounted access to the Garden Bar and Isabella's Restaurant will be available on a first come basis. To secure your discount you must register prior to the event as access will not be guaranteed on the day. All alcohol purchases on a concert day are at concert bar prices – no membership discounts apply. Member benefits and discounts for all membership types are not valid on concert and event days unless specified.



## **Membership Continuation:**

Rochford Wines will contact you four (4) weeks prior to the delivery of your next forward order. The minimum membership commitment is 12 months and your membership program will automatically renew annually unless you request to opt out. Please call or email to discuss any changes to your membership program, or to cancel your Membership. If you fail to communicate with Rochford Wines via phone, email, SMS or other, and do not return Rochford Wines' communication, it will be assumed your membership will automatically continue and your preferences for wines in previous orders will be replicated.

All wines or other goods ordered remain the property of Rochford Wines until payment is received in full. Our total liability to you for non-delivery of purchased goods is limited to the purchase price of the products.

Rochford Wines shall not be liable for any delay in delivering your wine if that delay or failure is caused by circumstances beyond our control such as war, riot, civil commotion, malicious damage, compliance with any current or future law or governmental order, rule, regulation or direction, fire, flood, storm or other poor weather conditions, Act of God, failure of ISP or telecommunications provider in connection with the performance of this Agreement.

Rochford Wines reserves the right to modify the terms, conditions and notices contained within the membership program without notice to you. Your continued participation within the membership program after any such change constitutes your agreement to such change. Rochford Wines Pty Ltd further reserves the right to change prices and other information on the website at any time without notice to you. The posting of prices and other terms of sale within the membership program or on the Rochford Wines website shall not constitute a binding agreement and Rochford Wines is not obliged to sell products on such terms.

## Credit Card Expired / Cancelled Credit Card or Incorrect Details:
